litigation strategy involving the suit with the Secretary of State and a litigation update involving annexation.

A motion was made by Councilmember Walker, duly seconded by Councilmember Pucheu to offer full settlement of pending litigation of City of Gulfport V. The Secretary of State in which the Governing Authority of the city hereby agrees to a negotiated Use Agreement for the Small craft Harbor (Water Bottoms; a Boundary Agreement to be executed by the Secretary of State removing any claim of State Tidelands to certain lands including 20th Avenue as improved and reconfigures; and the City agreeing to a Perpetual Dedication and Grant for Public Use and Park document for all lands included in the Boundary Agreement:

AND it is agreed that final negotiated documents shall be officially ratified by the Governing Authority, signed and executed by the parties in substantially the form and content of the final negotiated documents after an official survey plat and description is revised to include the properties agreed to for each document;

AND FURTHER, it shall be understood by the parties that agreements shall then be approved and executed for the City's development and public use of areas located at Courthouse Road extended and Cowan Road extended;

AND this offer requires immediate acceptance by the Secretary of State to abate any further litigation, trial or pre-trial proceedings in Court pending final ratification and signing of the final negotiated agreements.
