

There came on for consideration at a duly constituted meeting of the Mayor and Members of the City Council of the City of Gulfport, Mississippi, held on the ____ day of _____, 2014, the following Resolution:

A RESOLUTION BY THE GULFPORT CITY COUNCIL DECLARING CERTAIN EQUIPMENT RELATED TO A DUI TRAILER, TO THE EXTENT THAT THE CITY HAS ANY OWNERSHIP THEREIN, AND AUTHORIZING THE TRANSFER OF SAID EQUIPMENT, IN COORDINATION WITH THE DEPARTMENT OF PUBLIC SAFETY, TO THE CITY OF STARKVILLE, MISSISSIPPI, AND AUTHORIZING THE APPROPRIATE PERSONNEL WITH THE GULFPORT POLICE DEPARTMENT TO EXECUTE ANY AND ALL DOCUMENTS THAT MAY BE REQUIRED TO EFFECTUATE THE SAID TRANSFER

WHEREAS, the City of Gulfport purchased a 20' Custom DUI Trailer, with generator, one (1) Gateway laptop computer and one (1) multi-function printer with funds received from Alcohol Countermeasure Grant 07-TA-21421 and a security system for the DUI Trailer with Alcohol Countermeasure grant 08-TA-2141 and City of Gulfport asset numbers were assigned to each of these items; and

WHEREAS, pursuant to the terms of the grant, resources and assets purchased with grant funds are the property of the Mississippi Department of Public Safety and held in trust for it by the City and the Department of Public Safety may transfer said resources/assets to another agency willing to use the equipment; and

WHEREAS, the City of Gulfport has no further need for the DUI Trailer and the aforementioned assets that were purchased for use in/with the DUI Trailer, and the same is surplus (to the extent that the City of Gulfport has any ownership interest therein), and has requested of the Department of Public Safety to transfer the DUI Trailer and related equipment to the Starkville Police Department, and has received approval for said transfer (see collective Exhibit "A" hereto).

NOW THEREFORE, BE IT RESOLVED BY THE MAYOR AND CITY COUNCIL OF THE CITY OF GULFPORT, MISSISSIPPI, AS FOLLOWS, TO WIT:

Section 1. That the matters, facts and things recited in the Preamble hereto are hereby adopted as the official findings of the Governing Authority.

Section 2. That the aforementioned assets be and the same are, to the extent the City of Gulfport has any ownership interest therein, be and the same are hereby declared to be surplus property of the Municipality and the transfer thereof, as approved by the Department of Public Safety, to the City of Starkville and the Starkville Police Department be and the same is hereby approved and that the appropriate Gulfport Police Department personnel authorized by the Police Chief are authorized to execute any and all documents as may be required to effectuate the transfer of the trailer.

Section 3. That this Resolution be, and it is hereby ordered to be spread on the minutes of the governing Authority, and to be in full force and effect immediately upon its passage and enactment according to law.

The Gulfport Police Department purchased a 20'Custom DUI trailer with a generator attached, (1) Gateway laptop computer and a multifunction printer in September 2007 on the Alcohol Countermeasure grant 07-TA-2141. In the 2008 grant 08-TA-2141 the department purchased a security system for they DUI trailer. The Department of Public Safety paid the Police Department back and therefore under State Law this equipment belongs to them and can be transferred by them to an agency willing to use the equipment.

The Gulfport Police Department placed an asset number on all the above equipment in order to be able to locate during audits. This trailer has not been used in several years and the Department of Public Safety is requesting the transferred to Starkville Police Department.
