The City of Gulfport is requesting an increase of \$6,150,000.00 in Katrina Supplemental Community Development Block Grant Funds from Mississippi Development Authority for eligible Community Revitalization Projects.

The proposed funding will be utilized to fund several new projects that encompass health and safety, alleviating flooding and drainage, and economic development. All projects funded with KCDBG funds must meet one of three national objectives: 1) benefits to low and moderate income persons; 2) aid in the elimination of slums and blight; and 3) to meet other community development needs having a particular urgency because existing conditions pose a serious and immediate threat to the health or welfare of the community where other financial resources are not available to meet such needs.
