A RESOLUTION BY THE GULFPORT CITY COUNCIL TO APPROVE SUMMARY CHANGE ORDER NO. 1 TO CONTRACT WITH SAUNDERS CONSTRUCTION, LLC, ON THE WATER MAIN RELOCATION IN PROPOSED ROW PROJECT FOR STATE ROUTE 601 AND TO AUTHORIZE THE MAYOR TO EXECUTE SAID CHANGE ORDER

WHEREAS, SAUNDERS CONSTRUCTION, LLC, was awarded the contract for the WATER MAIN RELOCATION IN PROPOSED ROW FOR STATE ROUTE 601 PROJECT located within the Biloxi River Estates area of the City of Gulfport; and

WHEREAS, certain and various changes to the contract as set forth in the attached Change Order #1 (which, along with memos from City Engineer Kris Riemann and Connie Debenport (Purchasing Manager), is incorporated herein and attached hereto as Exhibit "A") are necessary to move forward with the project and reflect an DECREASE in costs to the city of \$37,142.00 with twelve (12) additional days added to the contract time.

Attached for your consideration is the referenced change order number 1, in the deductive amount of \$37,142.00 and additive amount of 12 calendar days of time. This change is required to adjust final quantities to reflect those actually used in the field for construction. The project was delayed due to the discovery of a 10-inch water main (originally believed to be 12-inch) along 16th Street, holidays, and weather.

The project is designed to relocate certain water utilities that currently exist in the proposed right of way of the SR 601 (Canal Road Connector) at Canal Road and Interstate 10. These water utilities must be relocated prior to construction of the new roadway and interchange.

MDOT has approved funding 100% of all costs of engineering, environmental, permitting, inspection, and construction associated with this project.
