ADDITIONAL BIOGRAPHICAL INFORMATION

I currently serve as the Managing Partner of the Gulfport office and am a member of the firm's Energy; Corporate & Securities; and Real Estate, Lending and Commercial practice groups. I enjoy a diverse practice and regularly represent clients in a wide variety of utility and commercial matters, including energy and utility litigation; energy regulation and transactions; water and sewer utility regulation, transactions, and litigation; business entity selection, formation, and operation; corporate finance; contract negotiation and administration; mergers and acquisitions; corporate compliance activities; securities matters; and real estate transactions.

In my energy and utility practice, I regularly appear before the Mississippi Public Service Commission and participate in filings submitted to the Federal Energy Regulatory Commission. I have been involved in numerous proceedings involving electric, water and sewer rate and tariff filings and contested rate cases, cost-based and market-based wholesale power transactions, applications for certificates of public convenience and necessity, transfers of jurisdictional property, rulemakings, and electric utility project development, regulatory approval, financing, construction, and operation.
