Based on our meeting today, and the modified EPA-approved budget dated February 7, 2014, we request an adjustment of **total shall not exceed** fees from \$346,000 to \$370,905.50, all of which is covered 100% by the referenced \$400,000 EPA grant. To date, our fees (as of end of February) have totaled \$258,924.80. All work performed under this grant must be completed by the end of September, 2014. At the City's request, we are currently conducting Phase I Environmental Sites Assessments (ESAs) on eight Section 16 parcels, all near or adjacent to the Chemfax site, six of which will be recommended for Phase II ESAs, and we are also facilitating a Brownfields Voluntary Agreement for Gulfport Tire facility at 1606 Pass Road. In addition, one Phase I ESA is planned for the Ameripride Site in downtown Gulfport. We are requesting this increase in allowable fees in order to cover expenses associated with this work and any other ESAs or redevelopment planning that the City may request.

This Letter Agreement represents a fee increase modification to our existing contract executed on February 23, 2012, between Neel-Schaffer, Inc. and the City of Gulfport. The agreement and exhibits of the original contract remain intact and may only be modified or amended by a duly executed written document.
