WHEREAS, the City of Gulfport, by and through its governing authority, does hereby congratulate all those who contributed to this exceptional season for the Gulfport High School

Admirals Boys' basketball team and expresses the pride of the City of Gulfport in the accomplishments of the players, coaches, administrators and all others who were a part of bringing this championship back home to Gulfport.

NOW THEREFORE, BE IT RESOLVED BY THE MAYOR AND CITY COUNCIL OF GULFPORT, MISSISSIPPI, AS FOLLOWS:
